CONTRACT AGREEMENT

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- Performance Security;
- Notice of Award of Contract; and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract,
- In consideration for the sum of Nine Hundred Ninety-Eight Pesos Only (P 998,000.00) 3. or such other sums as may be VCDU Prince Hotel, Inc. agrees to the Procurement of Meals, Venue & Accommodation for the conduct of DA Special Area for Agricultural Development (SAAD) Program Phase 2 FY 2024 National 1st Quarter Physical & Financial Assessment in accordance with his/her/its Bid.
- The **Department of Agriculture-Caraga Region** agrees to pay the above-mentioned 4. sum in accordance with the terms of the Bidding.
