



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF DRUGS AND BIOLOGICS (I3)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Drugs and Biologics under LIVESTOCK-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Two Million Nine Hundred Forty-Seven Thousand Nine Hundred Forty-Five Pesos (₱ 2,947,945.00)** which was group into two (2) lots;

Lot 1: Various Animal & Zoological Supplies	Php 1,778,945.00
Lot 2: Anti-Protozoans/Trypanocide	Php 1,169,000.00

WHEREAS, an opening of bids was conducted on October 21, 2024, 9:00 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was one (1) bidder who bought and submitted its bid, namely, P&J Agricultural Trading rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 23, 2024, the BAC determined that the bid submitted by P&J Agricultural Trading for Lot 1 as the Single Calculated Bid and subjected for post qualification and No Bidder for Lot 2;


WHEREAS, the BAC together with the TWG conducted on November 14, 2024 the post qualification to P&J Agricultural Trading for Lot 1 having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on November 20, 2024, it was declared that P&J Agricultural Trading, had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;




