BAC RESOLUTION RECOMMENDING AWARD FOR PROCUREMENT OF MATERIALS FOR THE CONSTRUCTION OF GREENHOUSE

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 08, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Materials for the Construction of Greenhouse under AMIA GAA 2024 with a total Approved Budget for the Contract (ABC) of One Million Fourteen Thousand Pesos (₱ 1,014,000.00); which was grouped into five (4) lots;

Lot 1: Materials for the Construction of Greenhouse (Jabonga, A D N)	Php	289,897.00
Lot 2: Materials for the Construction of Greenhouse (Lanuza, Surigao del Sur)	Php	289,897.00
Lot 3: Materials for the Construction of Greenhouse (Tubajon, PDI)	Php	289,897.00
Lot 4: Materials for the Construction of Greenhouse (San Francisco, SDN)	Php	144,948.00

WHEREAS, an opening of bids was conducted on December 02, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bidders who bought and submitted its bid, namely, CE Future Builders Corp., EJOB Construction & Supply, and LGTD Company OPC, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 09, 2024, the BAC determined that the bid submitted by CE Future Builders Corp for Lot 1, Lot 2, Lot 3 and Lot 4 as the Lowest Calculated Bid and both will be subjected for post qualification;

WHEREAS, the BAC together with the TWG conducted on December 11, 2024, the post qualification to CE Future Builders Corp. for Lot 1, Lot 2, Lot 3, ang Lot 4, having declared the lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on December 13, 2024, it was declared that CE Future Builders Corp. for Lot 1, Lot 2, Lot 3 and Lot 4 had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *procurement of Materials for the Construction of Greenhouse to* CE Future Builders Corp., as its bid was considered the Lowest Calculated and Responsive Bid;
