## BAC RESOLUTION RECOMMENDING AWARD FOR PROCUREMENT OF PROCUREMENT OF 6 UNITS FORAGE CHOPPER (K16)

Resolution No. 183 -2024 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 08, 2024, and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 6-Units Forage Chopper under Livestock GAA 2024 with a total Approved Budget for the Contract (ABC) of Two Million Eighty-Nine Thousand Three Hundred-Eighty Pesos (P 2,089,3800.00);

WHEREAS, a pre-bid conference was held virtually through <a href="https://bit.ly/prebid Code]-10212024">https://bit.ly/prebid Code]-10212024</a> last November 18, 2024 as scheduled;

WHEREAS, an opening of bids was conducted on December 02, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bidder who bought and submitted its bid, namely, Davao Techno Craft, received, rated as passed and subsequently subjected to a detailed evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 9, 2024, the BAC determined that the bid submitted by Davao Techno Craft as the Single Calculated Bid and will be subjected for post qualification;

WHEREAS, the BAC together with the TWG conducted on December 11, 2024, the post qualification to Davao Techno Craft, having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on December 13, 2024, it was declared that Davao Techno Craft had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the procurement of 6-Units Forage Chopper to Davao Techno Craft, as its bid was considered the Single Calculated and Responsive Bid;
