BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENTOF VARIOUS VEGETABLE SEEDS (H12)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last September 02, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Vegetable Seeds under AMIA GAA 2024 with a total Approved Budget for the Contract (ABC) of One Million Five Hundred Seventy-Six Nine Hundred Eighty-Eight Thousand Pesos (§ 1,576,988.00);

WHEREAS, an opening of bids was conducted on October 02, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids from Acacia Agriventures & Trading Corp., Ramgo Intl Corp. and Allied Botanical Corporation, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 10, 2024, the BAC determined that the bid submitted by Allied Botanical Corporation as the lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on October 29, 2024 the post qualification to Allied Botanical Corporation, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on November 5, 2024, it was declared that Allied Botanical Corporation had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Vegetable Seeds* to Allied Botanical Corporation, as its bid was considered the Lowest Calculated and Responsive Bid;
