BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS PLANTING MATERIALS (G6)

**Resolution No. 096-2024
Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Planting Materials under HVCDP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Two Million One Hundred Thousand Pesos (P 2,100,000.00)** which was grouped into two (2) lots;

Lot 1: Grafted Cacao Seedling	Php 1,600,000.00
Lot 2: Coffee Planting Material (Robusta)	Php 500,000.00

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids from JMC Plant Nursery, Bebot Rubber Nursery and Pelf Plant Nursery, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Pelf Plant Nursery as the Single Calculated Bid for Lot 1 and JMC Plant Nursery & Bebot Rubber Nursery both offered identical Lowest Calculated Bid and subject for post qualification;


WHEREAS, the BAC together with the TWG conducted on August 27, 2024 the post qualification to Pelf Plant Nursery having declared as Single Calculated Bid for Lot 1 and JMC Plant Nursery & Bebot Rubber Nursery as identical Lowest Calculated Bid for Lot 2 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was determined that the bid submitted by Pelf Plant Nursery is none responsive due to unavailability of one (1) clone variety out of (3) varieties required, thus declared failed for the post qualification requirements for Lot 1. Declared JMC Plant Nursery passed the post qualification requirements and considered the Lowest Calculated and Responsive Bid for Lot 2 by way of Appendix 11 of GPPB Circular 06-2005, Sec U 3.0, which outlines the tie breaking method such as draw lots or toss coin which was won by JMC Plant Nursery;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Various Planting Materials for Lot 2 to JMC Plant Nursery, as its bid was considered the Lowest Calculated and Responsive Bid;
