## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 25,000 HEADS CHICKEN (READY-TO-LAY PULLETS) WITH PRE-FABRICATED CAGE (G28)

Resolution No. 10)-1014 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 25,000 heads Chicken (Ready-to-Lay Pullets) with Pre-Fabricated Cage under LIVESTOCK-GAA 2024 with a total Approved Budget for the Contract (ABC) of Twenty Three Million Six Hundred Twenty Five Thousand Pesos (P 23,625,000.00) which was grouped into five (5) lots;

Lot 1: 500 heads for Province of Dinagat Islands	Php 4,725,000.00
Lot 2: 500 heads for Province of Surigao del Norte	Php 4,725,000.00
Lot 3: 500 heads for Province of Surigao del Sur	Php 4,725,000.00
Lot 4: 500 heads for Province of Agusan del Sur	Php 4,725,000.00
Lot 5: 500 heads for Province of Agusan del Norte	Php 4,725,000.00

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bidders who bought and submitted its bid, namely, Juniel's Farm, Tommy's Hog and Cattle, Julimon International Agri Trading Corporation, CJP Enterprises received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Tommy's Hog and Cattle as the Lowest Calculated Bid and subjected for post qualification;

WHEREAS, the BAC together with the TWG conducted on August 27, 2024 the post qualification to Tommy's Hog and Cattle having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was declared that Tommy's Hog and Cattle had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

WHEREAS, the financial component of the above four (4) bids rated as "passed" were opened and read as indicated on the abstract of bids which will be subjected to a detailed bid evaluation;
