BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF PERIMETER FENCE (G14)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of Perimeter Fence under LIVESTOCK-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Pesos (P 1,000,000.00)**;

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bidders who bought and submitted its bid, namely, C & R Construction & Supply and Moonlight Marketing & Construction Supply rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by C & R Construction & Supply has the lowest but rated Failed due to none declaration of DA-implemented projects on the Statement of All On-going and Awarded contracts, while Moonlight Marketing & Construction Supply is the 2nd Lowest Calculated Bid and subject for post qualification;


WHEREAS, the BAC together with the TWG conducted on August 21, 2024 the post qualification to Moonlight Marketing & Construction Supply having declared the 2nd Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was declared that Moonlight Marketing & Construction Supply had passed the post qualification requirements and was considered the 2nd Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Labor and Materials for The Construction of Perimeter Fence* to Moonlight Marketing & Construction Supply as its bid was considered the 2nd Lowest Calculated and Responsive Bid;
