BAC RESOLUTION RECOMMENDING AWARDFOR THE PROCUREMENT OF 100 HEADS PIGLETS (G34)

Resolution No. 109-2024 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 100 heads Piglets under LIVESTOCK-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Four Pesos (P 1,000,000.00)**;

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bidders who bought and submitted its bid, namely, Julimon International Agri Trading Corporation and Nanno's Integrated Farm, received, rated as passed and subsequently subjected to a detailed evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Julimon International Agri Trading Corporation as the lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on August 28, 2024 the post qualification to Julimon International Agri Trading Corporation having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was declared that Julimon International Agri Trading Corporation had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award to Julimon International Agri Trading Corporation the Procurement of 100 heads piglets, as its bid was considered the Lowest Calculated and Responsive Bid;
