**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS FERTILIZERS AND CHEMICALS (G1)**

**Resolution No.** 111-2024  
**Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Fertilizers And Chemicals under HVCDP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Three Million Five Hundred Fifty Nine Thousand and Forty Pesos (P 3,559,040.00)** which was grouped into two (2) lots;

<b>Lot 1:</b> Calcium Nitrate	Php 2,587,500.00
<b>Lot 2:</b> Various Chemicals	Php 971,540.00

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bidders who bought and submitted its bid, namely Jeels Masagana Farm Supply, Inc, Agri Bunch Products OPC and Do's Asia Chemical Trading Corporation for Lot 1, and two (2) bidders who bought and submitted its bid, namely, Jeels Masagana Farm Supply, Inc and Do's Asia Chemical Trading Corporation for Lot 2;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Agri Bunch Products OPC as the Lowest Calculated Bid for Lot 1 and Jeels Masagana Farm Supply, Inc as the Lowest Calculated Bid for Lot 2, and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on September 4, 2024, the post qualification to Agri Bunch Products OPC having declared the Lowest Calculated Bid for Lot 1 and Jeels Masagana Farm Supply, Inc as the Lowest Calculated Bid for Lot 2, to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was noted that the FPA Product Registration of Agri Bunch Products OPC had expired during the visit, as the First Cote PLUS is only valid until September 10, resulting to its disqualification for Lot 1. While Jeels Masagana Farm Supply, Inc. had passed the post qualification requirements and was considered the 2<sup>nd</sup> Lowest Calculated and Responsive Bid;

Mangelen, to award the *Procurement of Various Fertilizers and Chemicals* to Jeels Masagana Farm Supply, Inc for both Lot 1 as its bid was considered the Second Lowest Calculated and Responsive Bid and Lot 2 as its bid considered the Lowest Calculated and Responsive Bid;
