BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS AGRICULTURAL INPUTS (G32)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Agricultural Inputs under CORN-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Three Million Four Hundred Ninety Five Thousand Pesos (P 3,495,000.00)** which was grouped into two (2) lots;

Lot 1: 500 bags Hybrid Corn Seeds	Php 3,000,000.00
Lot 2: 450 bottles Pesticide	Php 495,000.00

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was one (1) bidder who bought and submitted its bid, namely, Aktiv Multi Trading Co. Phil. Inc;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Aktiv Multi Trading Co. Phil. Inc. for Lot 1 as the Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on August 29, 2024 the post qualification to Aktiv Multi Trading Co. Phil. Inc., having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was declared that Aktiv Multi Trading Co. Phil. Inc., had passed the post qualification requirements FOR Lot 1 and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award to Aktiv Multi Trading Co. Phil. Inc. the Procurement of Various Agricultural Inputs for Lot 1 as its bid was considered the Single Calculated and Responsive Bid;
