## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF CHICKEN AND GOAT FEEDS (G29)

Resolution No. 113- 1024
Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Chicken & Goat Feeds under LIVESTOCK-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Eleven Million Four Thousand Seven Hundred Fifty Pesos (P 11,004,750.00)** which was grouped into four (4) lots;

Lot 1: Layer Crumble	Php	9,075,000.00
Lot 2: 500 heads for Province of Surigao del Norte	Php	1,293,750.00
Lot 3: 500 heads for Province of Surigao del Sur	Php	300,000.00
Lot 4: 500 heads for Province of Agusan del Sur	Php	366,000.00

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bidders who bought and submitted its bid, namely, Julimon International Agri Trading Corporation and Hiron's General Merchandise received, rated as passed and subsequently subjected to a detailed bid evaluation:

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Julimon International Agri Trading Corporation as the Lowest Calculated Bid for Lot 1 and Hiron's General Merchandise for Lot 2 as the Lowest Calculated Bid and both will be subjected for post qualification;

WHEREAS, the BAC together with the TWG conducted on August 28, 2024 the post qualification to Julimon International Agri Trading Corporation as the Lowest Calculated Bid for Lot 1 and Hiron's General Merchandise for Lot 2 as the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was declared that Julimon International Agri Trading Corporation for Lot 1 and Hiron's General Merchandise for Lot 2 had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Chicken and Goat Feeds* to Julimon International Agri Trading Corporation for Lot 1 and Hiron's General Merchandise for Lot 2 as both bids were considered the Lowest Calculated and Responsive Bid;
