BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS AGRICULTURAL INPUTS FOR CORN (I4)

Resolution No. 124-2024
Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024, and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Agricultural Inputs for Corn under CORN-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Two Million Seven Hundred Ninety-Three Thousand Three Hundred Eighty-Four Pesos (₱ 2,793,384.00)** which was group into three (3) lots;

Lot 1: Hybrid Corn Seeds (NSIC 2023 GMCn 89)	Php 540,000.00
Lot 2: Hybrid White Corn Seeds	Php 861,000.00
Lot 3: Complete Fertilizer	Php 1,392,384.00

WHEREAS, an opening of bids was conducted on October 21, 2024, 9:00 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bidders who bought and submitted its bid, namely, OJM Seeds & Agricultural Services, Miracle Hybrid Corn Seed, Aktiv Multi Trading Co. Phils. Inc., FARCO MPC rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 23, 2024, the BAC determined that the bid submitted by Aktiv Multi Trading Co. Phils. Inc. for Lot 1, Miracle Hybrid Corn Seed for Lot 2 as the Lowest Calculated Bid were subject for post qualification, while OJM Agriventures for Lot 3 was declared ineligible as their PhilGEPS registration had expired during the evaluation process.

WHEREAS, the BAC together with the TWG conducted on November 20, 2024 the post qualification to Aktiv Multi Trading Co. Phils. for Lot 1 and Miracle Hybrid Corn Seed for Lot 2 having declared as the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on November 22, 2024, it was declared that Aktiv Multi Trading Co. Phils. for Lot 1 and Miracle Hybrid Corn Seed for Lot 2 had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various Agricultural Inputs for Corn* to Aktiv Multi Trading Co. Phils. for Lot 1 and Miracle Hybrid Corn Seed for Lot 2 as the Lowest Calculated and Responsive Bid;


