



**BAC RESOLUTION RECOMMENDING AWARD FOR THE
G30/C19 PROCUREMENT OF VARIOUS AGRICULTURAL INPUTS LOT 1- 385 BAGS RICE
SEEDS AND LOT 2- 688 KILOGRAMS COMPOST WORM
(NEGOTIATED PROCUREMENT)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 13, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the G30/C19 Procurement of 385 Bags Rice Seeds and 688 kgs Compost Worm under OAP-GAA 2024 with a total Approved Budget for the Contract (ABC) of One Million Three Hundred Fifty Thousand and Five Hundred Sixty Pesos (₱1,350,560.00);

WHEREAS, pre-negotiation was conducted on November 14, 2024 through face-to-face and virtual at DA13 Conference Hall, Butuan City and <https://bit.ly/negotiation-11142024> respectively.

WHEREAS, closing of posting and opening of bids was conducted on November 18, 2024 through virtual, <https://tinyurl.com/OpeningNego11182024>;

WHEREAS, there was only one (1) bidder who bought and submitted its bid, the Sto. Niño MPC;

WHEREAS, upon opening of the bid, the BAC members examined the submitted technical component to verify the presence or absence of the required documents and was rated as "Passed";

WHEREAS, the financial component was opened and read as indicated in the abstract of bid which will be subjected to a detailed bid evaluation;

WHEREAS, the preliminary deliberation was conducted face-to-face at DA13 Conference Hall, Butuan City on November 25, 2024;

WHEREAS, the post qualification was conducted face-to-face to Sto. Niño MPC in Brgy. Sto. Niño, Butuan City, to verify authenticity of the submitted documentary requirements and to check the availability of stocks on December 2, 2024;

WHEREAS, upon final deliberation conducted by the BAC members face-to-face at DA13 Conference Hall, Butuan City on December 9, 2024, it was declared that the lone bidder, Sto Niño MPC had "Passed" the post qualification requirements;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the G30/C19 Procurement of 15,400 kgs. Rice Seeds and 688 kgs Compost Worm to Sto. Niño MPC as its bid was the lone and responsive bid;
