**BAC RESOLUTION RECOMMENDING AWARD FOR PROCUREMENT
 OF SUPPLY, INSTALLATION AND COMMISSIONING
 OF 1-UNIT COLD STORAGE (K13)**

**Resolution No. 129-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 08, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Supply, Installation and Commissioning of 1-Unit Cold Storage under Rice GAA 2024 with a total Approved Budget for the Contract (ABC) of **Six Million Pesos (P 6,000,000.00)**;

WHEREAS, an opening of bids was conducted on December 02, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bidders who bought and submitted its bid, namely, Sanden Cold Chain System Phil Inc., YRME Refrigeration, and Shock and Awe Industrial Corp. received, rated as passes and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 9, 2024, the BAC determined that the bid submitted by INTELEQ INC. was disqualified and ineligible for post qualification due to non-compliance to technical specs to write 'Comply' per parameter and the bids submitted by Shock and Awe Industrial Corp as the Lowest Calculated Bid and will be subjected for post qualification;

WHEREAS, the BAC together with the TWG conducted on December 11, 2024, the post qualification to Shock and Awe Industrial Corp., having declared the lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on December 13, 2024, it was declared that to Shock and Awe Industrial Corp. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *procurement of Supply, Installation and Commissioning of 1-Unit Cold Storage* to Shock and Awe Industrial Corp., as its bid was considered the Lowest Calculated and Responsive Bid;
