



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 192 HEADS GOAT (UPGRADED) (H4)

Resolution No. 132-2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last September 12, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 192 heads Goat (Upgraded) under LIVESTOCK GAA 2024 with a total Approved Budget for the Contract (ABC) of **Four Million Eight Hundred Sixty Thousand Pesos (P 4,860,000.00)** which was grouped into five (5) lots;

Lot 1: 32 heads for Province of Dinagat Islands	Php 810,000.00
Lot 2: 32 heads for Province of Surigao del Norte	Php 810,000.00
Lot 3: 32 heads for Province of Surigao del Sur	Php 810,000.00
Lot 4: 32 heads for Province of Agusan del Sur	Php 810,000.00
Lot 5: 64 heads for Butuan City and Agusan del Norte	Php 1,620,000.00

WHEREAS, an opening of bids was conducted on October 02, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were there were three (3) bidders who bought and submitted its bid, namely, Sagana Farm, Julimon Int'l Agri Trading Corp and Nancio Farm Livestock Trading rated as passed and subsequently subjected to a detailed evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 10, 2024, the BAC determined that the bid submitted by Nancio Farm Livestock Trading Inc. for Lot 1 to Lot 4 and Sagana Farm for Lot 5 both are the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on October 29-30, 2024 the post qualification to Nancio Farm Livestock Trading Inc. for Lot 1 to Lot 4 and Sagana Farm for Lot 5 both are having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on November 8, 2024, it was declared that Nancio Farm Livestock Trading Inc. failed the post qualification requirements for Lot 1 to 4 due to the absence of AWA Registration Certificate during the post-qualification evaluation, citing that the certificate is under ongoing renewal, While Sagana Farm passed the post-qualification requirements for Lot 5 and was considered the Lowest Calculated and Responsive Bid;

WHEREAS, upon deliberation of the detailed bid evaluation on December 2, 2024, the BAC determined that the bid submitted by Julimon Int' Agri Trading Corp for Lot 1 & 2 and Sagana Farms for Lot 3 & 4 are the second lowest calculated bid and subject to post qualification.

WHEREAS, the BAC together with the TWG conducted the post-qualification on December 4, 2024, to Julimon Int'l Agri Trading Corp for Lot 1 & 2, and Sagana Farms for Lot 3 & 4 having declared the second lowest calculated bid to determine its capability to supply the contract if awarded;

WHEREAS, upon the final deliberation conducted by the BAC Members on December 9, 2024, it was declared that Julimon Int'l Agri Trading Corp for Lot 1 & 2 and Sagana Farms for Lot 3 & 4 had passed the post qualification requirements and was considered as the second lowest and responsive bid;

NOW, THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of 192 Heads of Goat (Upgraded)* to Julimon Int'l Agri Trading Corp for Lot 1 & 2, Sagana Farms for Lot 3, 4 & 5 as its bid was considered the Lowest Calculated and Responsive Bid;
