

**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF TWELVE  
(12) UNITS SOYBEAN SORTER (C7/A67)**

**Resolution No. 071-2024  
Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Twelve (12) units Soybean Sorter under Corn-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Six Million Pesos (P6,000,000.00)**.

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from ACT (Machineries and Metal Craft) Corporation, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by ACT (Machineries and Metal Craft) Corporation as the Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 23, 2024 the post qualification to ACT (Machineries and Metal Craft) Corporation, having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that ACT (Machineries and Metal Craft) Corporation, had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Twelve (12) units Soybean Sorter to ACT (Machineries and Metal Craft) Corporation as its bid was considered the Single Calculated and Responsive Bid;


