

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 16 UNITS MULTI-COMMODITY DRYING FACILITY (C15)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 16 units Multi-Commodity Drying Facility under HVCDP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Three Million Two Hundred Thousand Pesos (P3,200,000.00)** grouped into two (2) lots;

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bids from BN Builders and Construction Supplies, Inc., Allyde Construction, Ilmar Construction & Supply, and AJP Builders & Supplies, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Ilmar Construction & Supply for Lot 1 and Lot 2 were declared as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 24, 2024 the post qualification to Ilmar Construction & Supply, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Ilmar Construction & Supply bid for Lot 1 and Lot 2, had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Lot 1 Cabadbaran City, Agusan del Norte - 4 units, RTR, Agusan del Norte - 2 unit and Buenavista, Agusan del Norte - 4 units and Procurement of Lot 2: Esperanza, Agusan del Sur - 2 units and Tagbina, Surigao del Sur - 4 units* to Ilmar Construction & Supply as its bid was considered the Lowest Calculated and Responsive Bid;
