**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 7 UNITS HYDROPONICS GREENHOUSE (USING DEEP WATER CULTURE) (C16)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 7 units Hydroponics Greenhouse (using Deep Water Culture) under NUPAP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Three Million One Hundred Fifty Thousand Pesos (P3,150,000.00)** grouped into two (2) lots;

**Lot 1:**

- 1. Butuan City, Agusan del Norte – 4 units - Php1,800,000.00

**Lot 2:**

- 1. San Jose, Province of Dinagat Islands – 1 unit - Php1,350,000.00
- 2. Basilisa, Province of Dinagat Islands – 1 unit
- 3. Cagdianao, Province of Dinagat Islands – 1 unit

WHEREAS, an opening of bids was conducted on on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Turbu Konstrack, Inc., received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Turbu Konstrack, Inc. for Lot 1, as the Single Calculated Bid and was subjected to post qualification while no bid received for Lot 2;

WHEREAS, pursuant to Section 35.1(b) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), the Bids and Awards Committee shall declare a failure of bidding when no bids are received, among others;

WHEREAS, the BAC together with the TWG conducted on April 29, 2024 the post qualification to Turbu Konstrack, Inc., having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Turbu Konstrack, Inc. bid for Lot 1, had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Lot 1: Butuan City, Agusan del Norte – 4 units* to Turbu Konstrack, Inc. as its bid was considered the Single Calculated and Responsive Bid;

FURTHER, the BAC recommends to the Head of Procuring Entity, Regional Executive Director Arlan M. Mangelen to declare failure of bidding for the *Procurement of Lot 2: San Jose, Province of Dinagat Islands – 1 unit, Basilisa, Province of Dinagat Islands – 1 unit and Cagdianao, Province of Dinagat Islands – 1 unit* under NUPAP and to review the specifications and ABC of the contract before the conduct of rebidding;
