BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE ESTABLISHMENT OF 3 UNITS SOLAR POWERED IRRIGATION SYSTEM (SPIS) (C18)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Establishment of 3 units Solar Powered Irrigation System (SPIS) under OAP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million One Hundred Eighty-Eight Thousand Pesos (P1,188,000.00)** grouped into three (3) lots;

- Lot 1: Gasa Solar Powered Irrigation System - Php440,000.00
- Lot 2: Marabon Solar Powered Irrigation System - Php442,000.00
- Lot 3: Villafranca Solar Powered Irrigation System - Php306,000.00

WHEREAS, an opening of bids was conducted on on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids from IRE Industrial Facilities Construction, JG-DM Construction and Supply and MDC Electrical Supplies and Services, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by IRE Industrial Facilities Construction as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 30, 2024 the post qualification to IRE Industrial Facilities Construction, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that IRE Industrial Facilities Construction, had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Lot 1: Gasa Solar Powered Irrigation System, Lot 2: Marabon Solar Powered Irrigation System and Lot 3: Villafranca Solar Powered Irrigation System* to IRE Industrial Facilities Construction as its bid was considered the Lowest Calculated and Responsive Bid;
