BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 4 UNITS MCDP (C11)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 4 units MCDP under Corn-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Eight Million Pesos (P8,000,000.00)** grouped into four (4) lots;

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bids from Ilmar Construction & Supply, MN Bayalas Construction, AJP Builders & Supplies, and BN Builders and Construction Supplies, Inc., received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by BN Builders and Construction Supplies for Lot 1 and Lot 2 as the Single Calculated Bid, Ilmar Construction & Supply for Lot 3 and AJP Builders & Supplies for Lot 4 as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 24, 2024 the post qualification to BN Builders and Construction Supplies for Lot 1 and Lot 2, Ilmar Construction & Supply for Lot 3 and AJP Builders & Supplies for Lot 4, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that BN Builders and Construction Supplies bid for Lot 1 and Lot 2, Ilmar Construction & Supply bid for Lot 3 and AJP Builders & Supplies bid for Lot 4, had passed the post qualification requirements and were considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Lot 1: 1-unit Buenavista, Agusan del Norte and Lot 2: 1-unit at Cabadbaran City, Agusan del Norte to BN Builders and Construction Supplies, Procurement of Lot 3: 1-unit at Santiago, Agusan del Norte to Ilmar Construction & Supply, and Procurement of Lot 4: 1-unit at Gigaguit, Surigao del Norte to AJP Builders & Supplies as its bid were considered the Lowest Calculated and Responsive Bid;


