**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 48,000 PIECES DURIAN SEEDLINGS (GRAFTED) (A5)**

**Resolution No. 086-2024  
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 48,000 pieces Durian Seedlings (Grafted) under HVCDP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Three Million Eight Hundred Forty Thousand Pesos (P3,840,000.00)**;

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bidders who bought and submitted its bid, namely, Paman Plant Nursery, Noybin Nursery and Marketing and Binahon Agroforestry Farm;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Binahon Agroforestry Farm as the Lowest Calculated Bid and subject for post qualification.

WHEREAS, the BAC together with the TWG conducted on January 31, 2024 the post qualification to Binahon Agroforestry Farm having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon deliberation conducted by the BAC members, it was found out that Binahon Agroforestry Farm has insufficient stocks on hand.

WHEREAS, the BAC considered the next lowest calculated bid of Noybin Nursery and Marketing, but did not pass the detailed evaluation due to non-compliance of technical specification.

WHEREAS, upon final deliberation conducted by the BAC members on May 7, 2024, it was declared that Paman Plant Nursery had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

WHEREAS, upon deliberation conducted by the BAC members on it was declared that Paman Plant Nursery had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 48,000 pieces Durian Seedlings (Grafted) to Paman Plant Nursery as its bid was considered the Lowest Calculated and Responsive Bid;
