BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT FOR THE CONSTRUCTION OF 15 UNITS CHICKEN LAYING HOUSE

Resolution No. 088-2024 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last June 28, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement Labor and Materials for the Construction of 15 Units Chicken Laying House under SAAD 2024 with a total Approved Budget for the Contract (ABC) of One Million Seventy-Six Thousand Pesos (P-3,750,000.00) which was grouped into two (2) lots;

Lot 1: 9 Units of Chicken Laying House at Province of Surigao del Norte	Php 2,250,000.00
Lot 2 : 6 Units of Chicken Laying House at Province of Dinagat Islands	Php 1,500,000.00

WHEREAS, an opening of bids was conducted on July 2, 2024, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were four (4) bidder participated in the negotiation for Lot 1 namely, C & R Construction and Supply, RMB Development Corporation, CAP J Construction and Allyde Construction, while three (3) bidders for Lot 2 namely, C & R Construction and Supply, RMB Development Corporation, and CAP J Construction which was subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on July 10, 2024, the BAC determined that the bid submitted by RMB Development Corporation is the Lowest Calculated and Responsive Bid for Lot 1 & Lot 2, and be subjected to post

WHEREAS, the BAC together with the TWG conducted on July 17-19, 2024 the post qualification to RMB Development Corporation having declared the Lowest Calculated and Responsive Bid for Lot 1 & Lot 2 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on July 26, 2024, it was declared that RMB Development Corporation had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid for Lot 1 & Lot 2;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement Labor and Materials for the Construction of 15 Units Chicken Laying House to RMB Development Corporation as its bid was considered the Lowest Calculated and Responsive Bid for Lot 1 & Lot 2;
