## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF DUCK FEEDS

Resolution No. 090-2024  
Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last June 28, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Duck Feeds under Livestock-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Four Hundred Fifty Seven Thousand Three Hundred Sixty Pesos (P1,457,360.00)**.

WHEREAS, an opening of bids was conducted on July 2, 2024, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were three (3) bidder participated in the negotiation namely, Hiron's General Merchandise, Chemar Marketing and Julimon International Agri Trading Corporation which was subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on July 10, 2024, the BAC determined that the bid submitted by Hiron's General Merchandise is the Lowest Calculated and Responsive Bid and be subjected to post qualification evaluation;

WHEREAS, the BAC together with the TWG conducted on July 17-19, 2024 the post qualification to Hiron's General Merchandise having declared the Lowest Calculated and Responsive Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on July 26, 2024, it was declared that Hiron's General Merchandise had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Duck Feeds to Hiron's General Merchandise as its bid was considered the Lowest Calculated and Responsive Bid;

RESOLVED, this 8<sup>th</sup> day of August 2024 at Butuan City, Philippines.


