BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT LABOR AND MATERIALS FOR THE CONSTRUCTION OF 1 UNIT COFFEE STORAGE (C14)

Resolution No. 091-2024 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 1unit Coffee Storage under HVCDP-GAA 2024 with a total Approved Budget for the Contract (ABC) of One Million Pesos (P1,000,000.00);

WHEREAS, an opening of bids was conducted on April 1, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only Three (3) bidders who bought and submitted its bid namely, BN Builders Construction Supplies, Inc., RMB Development Corporation and AC Dupa

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by RMB Development Corporation, as the Lowest Calculated Bid and was subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 29, 2024 the post qualification to RMB Development Corporation, having declared the Lowest Calculated Bid to determine its capability to perform the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was noted that the RMB Development Corporation, has issues on their on-going project which is also funded by HVCDP, the BAC agreed to subject the bidder for a further technical evaluation and discussion;

WHEREAS, a second final deliberation was conducted by the BAC members on July 8, 2024, was declared that RMB Development Corporation had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Labor and Materials for the Construction of 1 unit Coffee Storage to RMB Development Corporation as its bid was considered the Lowest Calculated and Responsive Bid;
