**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF
 LOWLAND VEGETABLE SEEDS (G4)**

Resolution No. 093-2024
 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Lowland Vegetable Seeds under HVCDP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Two Million Four Hundred Seventy Seven Thousand Four Hundred Eighty Six Pesos (P 2,477,486.00)** which was grouped into two (2) lots;

Lot 1: Procurement of Assorted Lowland Vegetables Seeds	Php 1,470,686.00
Lot 2: Procurement of Assorted Lowland Vegetables Seeds for Buffer Stocking	Php 1,006,800.00

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bidders who bought and submitted its bid, namely, RAMGO International Trading Corporation received and rated as failed, Allied Botanical Corporation, and Farmers Edge Agriventures, Inc received and rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Allied Botanical Corporation as the Lowest Calculated Bid for Lot 1 and Lot 2 and subject for post qualification;


WHEREAS, the BAC together with the TWG conducted on September 4, 2024, the post qualification to Allied Botanical Corporation having declared the Lowest Calculated Bid for Lot 1 and Lot 2 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was declared that Allied Botanical Corporation, had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid for Lot 1 and Lot 2;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Lowland Vegetable Seeds* to Allied Botanical Corporation as its bid was considered the Lowest Calculated and Responsive Bid;
