## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS ICT EQUIPMENT (G11)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 19, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various ICT Equipment under PMED-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Twenty Four Thousand Pesos (P 1,524,000.00)**;

WHEREAS, an opening of bids was conducted on August 09, 2024, 9:15 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bids from Dataworld Computer Center, Fast Tech Computer, Vocom Enterprises and Solidmark, Inc, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on August 16, 2024, the BAC determined that the bid submitted by Solidmark, Inc as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on August 29, 2024 the post qualification to Solidmark, Inc., having declared the Lowest Calculated Bid to determine its capabilty to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 13, 2024, it was declared that Solidmark, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Various ICT Equipment* to Solidmark, Inc. as its bid was considered the Lowest Calculated and Responsive Bid;
