BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 5 UNITS MUSHROOM GROWING HOUSE (A14)

**Resolution No. 003-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 14, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 5 units Mushroom Growing House – Short of Award under NUPAP-NEP 2024 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Thousand Pesos (₱1,500,000.00)** grouped into two (2) lots;

- Lot 1: Labor and Materials for the Construction of 3 units -Php900,000.00
 Mushroom Growing House at Butuan City*
- Lot 2: Labor and Materials for the Construction of 2 units -Php600,000.00
 Mushroom Growing House at Bayugan City and
 San Francisco, Agusan del Sur*

WHEREAS, an opening of bids was conducted on December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from ACDupa Construction Services and Stef Construction received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by ACDupa Construction Services for Lot 1 and Lot 2 as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 9, 2024 the post qualification to ACDupa Construction Services having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2024, it was declared that ACDupa Construction Services had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Labor and Materials for the Construction of 5 units Mushroom Growing House, Lot 1 and Lot 2* to ACDupa Construction Services as its bid was considered the Lowest Calculated and Responsive Bid;
