



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 80 ROLLS
 UV PLASTIC SHEETS (A17)**

**Resolution No. 004-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 80 rolls UV Plastic Sheets – under OAP- GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Pesos (P1,000,000.00)**;

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) from Aktiv Multi Trading Co., Phils., Inc. and Metos Offshore, Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Aktiv Multi Trading Co., Phils., Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 18, 2024 the post qualification to Aktiv Multi Trading Co., Phils., Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2024, it was declared that Aktiv Multi Trading Co., Phils., Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 80 rolls UV Plastic Sheets* to Aktiv Multi Trading Co., Phils., Inc. as its bid was considered the Lowest Calculated and Responsive Bid;


