**BAC RESOLUTION RECOMMENDING AWARD PROCUREMENT OF 2,220 BAGS LAYER (CRUMBLE) FOR SAAD (A35)**

**Resolution No. 006-2024**  
**Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 2,220 bags Layer (Crumble) for SAAD – Short of Award under SAAD-NEP 2024 with a total Approved Budget for the Contract (ABC) of **Four Million Eight Hundred Eighty-Four Thousand Pesos (P4,884,000.00)** grouped into five (5) lots;

<i>Lot 1: 60 bags Layer (Crumble)</i>	<i>-Php132,000.00</i>
<i>Lot 2: 420 bags Layer (Crumble)</i>	<i>-Php924,000.00</i>
<i>Lot 3: 1,020 bags Layer (Crumble)</i>	<i>-Php2,244,000.00</i>
<i>Lot 4: 480 bags Layer (Crumble)</i>	<i>-Php1,056,000.00</i>
<i>Lot 5: 240 bags Layer (Crumble)</i>	<i>-Php528,000.00</i>

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Hiron's General Merchandise received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Hiron's General Merchandise for Lot 1, Lot 2, Lot 3, Lot 4 and Lot 5 as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 16, 2024 the post qualification to Hiron's General Merchandise having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2024, it was declared that Hiron's General Merchandise had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of *Lot 1: 60 bags Layer (Crumble), Lot 2: 420 bags Layer (Crumble), Lot 3: 1,020 bags Layer (Crumble), Lot 4: 480 bags Layer (Crumble), and Lot 5: 240 bags Layer (Crumble)* to Hiron's General Merchandise as its bid was considered the Single Calculated and Responsive Bid;
