**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 3,552 HEADS READY TO LAY PULLETS WITH PRE-FABRICATED CAGE (A39)**

**Resolution No. 007-2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the **Procurement of 3,552 heads Ready to Lay Pullets with Pre-Fabricated Cage – Short of Award under SAAD-NEP 2024 with a total Approved Budget for the Contract (ABC) of Three Million Five Hundred Fifty-Two Thousand Pesos (₱3,552,000.00)**;

WHEREAS, an opening of bids was conducted on on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bids from Juniel's Farm & Agrivet Supplies, Tommy's Hogs & Cattle, Julimon International Agri Trading Corp., and Abastillas Livestock received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Tommy's Hogs & Cattle as the Lowest Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on January 18, 2024 the post qualification to Tommy's Hogs & Cattle having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2024, it was declared that Tommy's Hogs & Cattle had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 3,552 heads Ready to Lay Pullets with Pre-Fabricated Cage* to Tommy's Hogs & Cattle as its bid was considered the Lowest Calculated and Responsive Bid;




