BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS ICT EQUIPMENT (A44)

**Resolution No. 008-2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 14, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various ICT Equipment – Short of Award under PMED-NEP 2024 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Forty-Nine Thousand Six Hundred Pesos (P1,249,600.00)**;

WHEREAS, an opening of bids was conducted on on December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were five (5) bids Fast Tech Computer Parts and Accessories Shop, Solidmark Inc., Dataworld Computer Center, Vocom Enterprises and Xitrix Computer Corporation received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by Solidmark Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 19, 2024 the post qualification to Solidmark Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2024, it was declared that Solidmark Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Various ICT Equipment* to Solidmark Inc. as its bid was considered the Lowest Calculated and Responsive Bid;
