WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 14, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Laboratory Equipment-under ILD GAA 2024 with a total Approved Budget for the Contract (ABC) of **Ten Million Pesos (P10,000,000.00)**;

WHEREAS, an opening of bids was conducted on December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from Molave Trading Corporation and Guill-Bern Corporation received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 29, 2023, the BAC determined that the bid submitted by Molave Trading Corporation as the Lowest Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on January 18, 2024 the post qualification to Molave Trading Corporation having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2024, it was declared that Molave Trading Corporation. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Various Laboratory Equipment to Molave Trading Corporation as its bid was considered the Lowest Calculated and Responsive Bid;






