



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 1,920 BAGS ORGANIC FERTILIZER (A4)**

**Resolution No. 020 - 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1,920 bags Organic Fertilizer -under HVCDP GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Three Hundred Forty-Four Thousand Pesos (P1,344,000.00)**;

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bids from EMLZ Trading, Goodfarms Trading Corporation, St. Padre Pios Garden and Phoenix Larrel Agriventures received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Goodfarms Trading Corporation as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on February 1, 2024 the post qualification to Goodfarms Trading Corporation having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 8, 2024, it was declared that Goodfarms Trading Corporation had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award *the Procurement of 1,920 bags Organic Fertilizer* to Goodfarms Trading Corporation as its bid was considered the Lowest Calculated and Responsive Bid;
