**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF ONE (1)
UNIT PASSENGER VAN VEHICLE – SHORT OF AWARD (A21)**

**Resolution No. 023-2024
Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 14, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of One (1) unit Passenger Van Vehicle –under GASS GAA 2024 with a total Approved Budget for the Contract (ABC) of **Three Million One Hundred Seventy-Five Thousand Pesos (P3,175,000.00)**;

WHEREAS, an opening of bids was conducted on December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Toyota Cagayan de Oro Incorporated received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by Toyota Cagayan de Oro Incorporated as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 29, 2024 the post qualification to Toyota Cagayan de Oro Incorporated Inc. having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 8, 2024, it was declared that Toyota Cagayan de Oro Incorporated had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of One (1) unit Passenger Van Vehicle* to Toyota Cagayan de Oro Incorporated as its bid was considered the Single Calculated and Responsive Bid;
