BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 17,500 KGS. FUNGICIDE (A32)

**Resolution No. 027-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 17,500 kgs. Fungicide under Rice-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Seventeen Million Five Hundred Thousand Pesos (P17,500,000.00)**;

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there, there were five (5) bids from LDA Agri Marketing, Mars Agri Ventures & Commodities, Inc., Jeels Masagana Farm Supply, Inc., GoodFarms Trading Corporation and Farmers Edge Agriventures Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Jeels Masagana Farm Supply, Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 9, 2024 the post qualification to Jeels Masagana Farm Supply, Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon deliberation conducted by the BAC members on January 26, 2024, it was found out that Jeels Masagana Farm Supply, Inc. was not responsive due to non-submission of the FPA License to Operate, thus its bid was declared disqualified;

WHEREAS, the BAC considered the next Lowest Calculated Bid of LDA Agri Marketing for post qualification on January 30, 2024 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 8, 2024, it was declared that LDA Agri Marketing had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 17,500 kgs. Fungicide* to LDA Agri Marketing as its bid was considered the Lowest Calculated and Responsive Bid;


