



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF INBRED RICE SEEDS (CERTIFIED) (A27)

Resolution No. 028-2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Inbred Rice Seeds (Certified) -under Rice Program GAA 2024 with a total Approved Budget for the Contract (ABC) of **Nine Million Eight Hundred Eighty Thousand Pesos (P9,880,000.00)** grouped into two (2) lots;

<i>Lot 1: 1,300 bags Inbred Rice Seeds (Certified)</i>	<i>-Php5,928,000.00</i>
<i>Lot 2: 1,950 bags Inbred Rice Seeds (Certified)</i>	<i>-Php3,952,000.00</i>

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Bayugan Seeds Center received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Bayugan Seeds Center for Lot 1 and Lot 2 as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 29, 2024 the post qualification to Bayugan Seeds Center having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 8, 2024, it was declared that Bayugan Seeds Center had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Lot 1: 1,300 bags Inbred Rice Seeds (Certified) and Lot 2: 1,950 bags Inbred Rice Seeds (Certified)* to Bayugan Seeds Center as its bid was considered the Single Calculated and Responsive Bid;


