**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 480 BAGS COMPLETE FERTILIZER AND 480 BAGS UREA (A19)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 480 bags Complete Fertilizer and 480 bags Urea –under 4Ks GAA 2024 with a total Approved Budget for the Contract (ABC) of **Two Million Four Hundred Forty-Eight Thousand Pesos (P2,448,000.00)**;

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from Jeels Masagana Farm Supply, Inc. and Modern Time Enterprises Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Jeels Masagana Farm Supply, Inc. as the Lowest Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on February 12, 2024 the post qualification to Jeels Masagana Farm Supply, Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 13, 2024, it was declared that Jeels Masagana Farm Supply, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 480 bags Complete Fertilizer and 480 bags Urea* to Jeels Masagana Farm Supply, Inc. as its bid was considered the Lowest Calculated and Responsive Bid;
