



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF DUCK AND CHICKEN FEEDS FOR RES TRENTO (A46)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Duck and Chicken Feeds for RES Trento under Livestock -GAA 2024 with a total Approved Budget for the Contract (ABC) of **Two Million Two Hundred Eight Thousand Eighty-Three Pesos (P2,208,083.00)** grouped into two (2) lots;

Lot 1: Duck Feeds - Php1,457,360.00
Lot 2: Chicken Feeds - Php750,723.00

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Julimon International & Agri Trading Corp. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 27, 2023, the BAC determined that the bid submitted by Julimon International & Agri Trading Corp. for Lot 2 as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 17, 2024 the post qualification to Julimon International & Agri Trading Corp. having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 16, 2024, it was declared that Julimon International & Agri Trading Corp. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Lot 2: Chicken Feeds* to Julimon International & Agri Trading Corp. as its bid was considered the Single Calculated and Responsive Bid;
