**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 31,000  
 PIECES ABACA PLANTING MATERIALS (SUCKERS) (A18)**

**Resolution No. 040-2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 13, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 31,000 pieces Abaca Planting Materilas (Suckers) under 4Ks-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Forty Thousand Pesos (P1,240,000.00)**;

WHEREAS, an opening of bids was conducted on December 4, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from Noybin Nursery and Marketing, and Ernie Agro Forest Nursery received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by Ernie Agro Forest Nursery as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 26, 2024 the post qualification to Ernie Agro Forest Nursery having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 13, 2024, it was declared that Ernie Agro Forest Nursery had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 31,000 pieces Abaca Planting Materilas (Suckers)* to Ernie Agro Forest Nursery as its bid was considered the Lowest Calculated and Responsive Bid;
