



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF MEALS WITH VENUE AND ACCOMMODATION FOR THE CONDUCT OF DA SPECIAL AREA FOR AGRICULTURAL DEVELOPMENT PROGRAM (SAAD) PHASE 2 FY 2024 NATIONAL 1ST QUARTER PHYSICAL AND FINANCIAL ASSESSMENT (B1)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 01, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Meals Venue and Accommodation for the conduct of DA Special Area for Agricultural Development Program (SAAD) Phase 2 FY 2024 National 1st Quarter Physical and Financial Assessment under SAAD Program-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million One Hundred Ninety-Nine Thousand Pesos (P1,199,000.00)**;

WHEREAS, an opening of bids was conducted on March 25, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from VCDU Prince Hotel, rated as passed and subsequently subjected to a detailed bid evaluation.

WHEREAS, upon deliberation of the detailed bid evaluation on March 25, 2024, the BAC determined that the bid submitted by VCDU Prince Hotel, Inc., as the Single Calculated Bid and was subjected to post qualification.

WHEREAS, the BAC together with the TWG conducted on March 26, 2024 the post qualification to VCDU Prince Hotel, Inc. having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on April 1, 2024, it was declared that VCDU Prince Hotel, Inc. had passed the post-qualification requirements and was considered the Single Calculated and Responsive Bid.

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of Meals Venue and Accommodation for the conduct of DA Special Area for Agricultural Development Program (SAAD) Phase 2 FY 2024 National 1st Quarter Physical and Financial Assessment to VCDU Prince Hotel, Inc. as its bid was considered the Single Calculated and Responsive Bid.




