UNITS HAULING VEHICLE FOR RICE (A56)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 14, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Six (6) units Hauling Vehicle for Rice under Rice Program-GAA 2024 with a total Approved Budget for the Contract (ABC) of Fourteen Million One Hundred Thousand Pesos (P14,100,000.00);

WHEREAS, an opening of bids was conducted on December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, three (3) bids from Alpine Motors Corp., Gap Construction & Development Corp., and Image Motors Davao del Norte Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by Alpine Motors Corp. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 31, 2024 the post qualification to Alpine Motors Corp. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 8, 2024, it was declared that Alpine Motors Corp. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Six* (6) units Hauling Vehicle for Rice to Alpine Motors Corp. as its bid was considered the Lowest Calculated and Responsive Bid;
