BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF FOUR (4) UNITS FARM TRACTOR FOR CORN (A65)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 15, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Four (4) units Farm Tractor for Corn under Corn Program-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Twelve Million Pesos (P12,000,000.00)**;

WHEREAS, an opening of bids was conducted December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Ford Tractor Phils., Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by Ford Tractor Phils., Inc. as the Single Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on February 1, 2024 the post qualification to Ford Tractor Phils., Inc. having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 8, 2024, it was declared that Ford Tractor Phils., Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award *Procurement of Four (4) units Farm Tractor for Corn* to Ford Tractor Phils., Inc. as its bid was considered the Single Calculated and Responsive Bid;






