



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF FOUR (4) UNITS HAULING VEHICLE FOR CORN (A66)

**Resolution No. 066-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 15, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Four (4) units Hauling Vehicle for Corn under Corn Program-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Twelve Million Pesos (P12,000,000.00)**;

WHEREAS, an opening of bids was conducted on December 5, 2023, 9:00 A. M. at the Covered Court, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids from Gap Construction & Development Co., Image Motors Davao del Norte Inc., and North-Min Auto Dealership, Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 28, 2023, the BAC determined that the bid submitted by North-Min Auto Dealership, Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 29, 2024 the post qualification to North-Min Auto Dealership, Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 8, 2024, it was declared that North-Min Auto Dealership, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;


