BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 644 BAGS HYBRID CORN SEED (YELLOW) (C4)

Resolution No. 069 - 1024 Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 644 bags Hybrid Corn Seeds (Yellow) under Corn-GAA 2024 with a total Approved Budget for the Contract (ABC) of Three Million Seven Hundred Ninety-Nine Thousand Six Hundred Pesos (P3,799,600.00);

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bids from Caraga Gen. Merchandise & Enterprises Corporation, Aktiv Multi Trading Co. Phils. Inc., BSC Consumer Goods Trading and Jedeco Trading Corporation, received, rated as passed and subsequently subjected to a detailed bid evaluation:

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Aktiv Multi Trading Co. Phils. Inc. as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 23, 2024 the post qualification to Aktiv Multi Trading Co. Phils. Inc., having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Aktiv Multi Trading Co. Phils. Inc., had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of 644 bags Hybrid Corn Seeds (Yellow) to Aktiv Multi Trading Co. Phils. Inc. as its bid was considered the Lowest Calculated and Responsive Bid;
