**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 12,245  
PACKS BIOFERTILIZER (C6)**

**Resolution No. 070-2024  
Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region published an Invitation to Bid on the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 12,245 packs Biofertilizer under Corn-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Thousand Ten Pesos (P1,200,010.00)**;

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from Agrispecialist, Inc. and Classique Herbs Corporation, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Classique Herbs Corporation as the Lowest Calculated Bid and subject to post qualification.

WHEREAS, the BAC together with the TWG conducted on April 29, 2024 the post qualification to the bid submitted by Classique Herbs Corporation, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Classique Herbs Corporation had passed the post-qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of 12,245 packs of Biofertilizer* to Classique Herbs Corporation as its bid was considered the Lowest Calculated and Responsive Bid;

RESOLVED, this 6<sup>th</sup> day of May 2024 at Butuan City, Philippines.


