



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF TWO (2) UNITS HAULING VEHICLE FOR CORN (WING VAN) (C8/A62)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Two (2) units Hauling Vehicle for Corn (Wing Van) under Corn-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Fifteen Million Pesos (P15,000,000.00)**;

WHEREAS, an opening of bids was conducted April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were five (5) bids from Hyundai Southern Mindanao Inc., GAP Construction & Dev't. Co., Image Motors Davao del Norte, Inc., Hino Butuan City, Inc. and CLARC Enterprises, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Image Motors Davao del Norte, Inc. as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 29, 2024 the post qualification to Image Motors Davao del Norte, Inc., having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Image Motors Davao del Norte, Inc., had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Two (2) units Hauling Vehicle for Corn (Wing Van)* to Image Motors Davao del Norte, Inc. as its bid was considered the Lowest Calculated and Responsive Bid;


