**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF HYBRID RICE SEEDS (C20)**

Resolution No. 074-2024  
Series of 2024

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Hybrid Rice Seeds under Rice-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Two Million Pesos (P2,000,000.00)** grouped into two (2) lots;

Lot 1: 200 bags Hybrid Rice Seeds (M78)	- Php1,000,000.00
Lot 2: 200 bags Hybrid Rice Seeds (M81)	- Php1,000,000.00

WHEREAS, an opening of bids was conducted April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from Aktiv Multi Trading Co. Phils. Inc. and SL Agritech Corporation, received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the BAC determined that the bid submitted by Aktiv Multi Trading Co. Phils. Inc. for Lot 1 and SL Agritech Corporation for Lot 2 as the Single Calculated Bid and were subjected for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 23 and April 30, 2024 the post qualification to Aktiv Multi Trading Co. Phils. Inc. for Lot 1 and SL Agritech Corporation for Lot 2, respectively, having both declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Aktiv Multi Trading Co. Phils. Inc. bid for Lot 1 and SL Agritech Corporation bid for Lot 2, had passed the post qualification requirements and both were considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement Lot 1: 200 bags Hybrid Rice Seeds (M78)* to Aktiv Multi Trading Co. Phils. Inc. while the *Procurement of Lot 2: 200 bags Hybrid Rice Seeds (M81)* to SL Agritech Corporation as both bids were considered the Single Calculated and Responsive Bid;


