



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF ONE (1) UNIT GAS CHROMATOGRAPH MASS SPECTROMETER (GC/MS) (C23/A49)

**Resolution No. 075-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of one (1) unit Gas Chromatograph Mass Spectrometer under ILD-GAA 2024 with a total Approved Budget for the Contract (ABC) of **Eight Million Six Hundred Thousand Pesos (P8,600,000.00)**;

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids received from Cebu Far Eastern Drug, Inc., Instrumix Supplier, Inc. and ITS Science (Phils) Inc., rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Instrumix Supplier, Inc., as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 23, 2024 a virtual post qualification to Instrumix Supplier, Inc., having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that Instrumix Supplier, Inc., had passed the post-qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the Procurement of One (1) unit Gas Chromatograph Mass Spectrometer to Instrumix Supplier, Inc. as its bid was considered the Lowest Calculated and Responsive Bid;




