



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF NURSERY FOR VEGETABLE SEEDLINGS (C1/A9)

**Resolution No. 035-2024
 Series of 2024**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 09, 2024 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of Nursery for Vegetable Seedlings under HVCDP-GAA 2024 with a total Approved Budget for the Contract (ABC) of **One Million Nine Hundred Thousand Pesos (P1,900,000.00)** grouped into two (2) lots;

- Lot 1: Butuan City - 3 units - Php1,425,000.00
- Lot 2: Tubod, Surigao del Norte - 1 unit - Php475,000.00

WHEREAS, an opening of bids was conducted on April 01, 2024, 9:10 A. M. at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids from Turbu Konstrak, Inc., RMB Development Corporation, and AJP Builders & Supplies, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 12, 2024, the BAC determined that the bid submitted by Turbo Konstrak Inc. and RMB Development Corporation for Lot 1 was declared non-responsive due to non-complying specifications and non-conformance to Sec. 23.4.2.4 of the Revised IRR of R.A. 9184, respectively while AJP Builders & Supplies bid for Lot 2 was declared as the Lowest Calculated Bid and subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 24, 2024 the post qualification to AJP Builders & Supplies, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 6, 2024, it was declared that AJP Builders & Supplies bid for Lot 2, had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Arlan M. Mangelen, to award the *Procurement of Lot 2: Tubod, Surigao del Norte - 1 unit* to AJP Builders & Supplies as its bid was considered the Lowest Calculated and Responsive Bid;

FURTHER, the BAC recommends to the Head of Procuring Entity, Regional Executive Director, Arlan M. Mangelen to declare failure of bidding for the *Procurement of Lot 1: Butuan City - 3 units* and to resort to negotiated procurement after the review of technical specifications;




